Savings Accounts

The account is referred to as "Share Account" A minimum balance of \$50.00 is required. Dividends for shares are paid quarterly on the last day of the month.

Christmas Club Accounts

A Christmas Club account is a special savings account designed to help you save money for Christmas. No withdrawal is allowed. Dividends are paid quarterly. Funds are made available in November.

Checking Accounts

The account is referred to as Draft Account. A monthly service fee of \$7.50 is charged at the end of the month. No dividends paid.
